Our sincere appreciation again is extended to those members of our volunteer fire departments and those supporting the work behind the front lines in educating about fire safety. Thank you for your efforts in strengthening this network. Highlights since the last bulletin include the following update.

The BC Lake Stewardship Society Conference co-hosted by GLARA at Watch Lake this June was in a word, great! The educational value of this event was positively overwhelming. The content has provided GLARA with increased scientific data to continue partnerships with your local and provincial governments on lake health monitoring. Thank you for your individual efforts in heightening commitments to lake stewardship values. GLARA will be developing opportunities to continue with data development related to lake level recording and expanding studies on Green and Watch Lakes related to water quality and development pressures. We expect to receive copies of conference presentations. When the data is complete, we will strive to get this information shared. i.e. fish stocking and species information.

The executive and I look forward to the reporting back on the OCP research completed to date by the consultants. We anticipate the forthcoming meeting on August 14<sup>th</sup> to be designed to educate the participants on the specifics of the development issues and suggested directions for our watershed. Your numbers are important, your ear to the reliability of the information, and your voice to confirm or to get clarification, is critically important to the value and success of this meeting. Please try to put the time aside.

The second date to put to the calendar is the GLARA annual general meeting on August 22nd. We will have the participation of the Electoral Area Directors and anticipate presentations from law enforcement, wild fire management, and a special guest speaker on a topic of common interest to all area residents.

To one and all of the GLARA directors and to all membership residents, thank you for your continued support and attention to the health and future of what draws our lives together – water, foreshore, trees, wildlife, and our back country values. 

## PLEASE DON'T FEED THE WILDLIFE

#### Wildlife diet fact sheet

- When animals come to rely on human food instead of their natural diet, their health suffers. Growth and development can be seriously disrupted if baby animals are fed the wrong foods.
- When wild animals are attracted to populated areas by food, they may become habituated and lose their healthy fear of people. This poses risks to both humans and wildlife (as well as pets). Most injuries treated by wildlife rehabilitation centres are human-related.
- Feeding wildlife disrupts normal population and migration patterns. Animals adapt to an artificial abundance of food, but when food becomes scarce, as in winter or when people stop feeding them, animals face starvation.
- -Feeding draws unnaturally large numbers of animals to the area of the food source. These gatherings can increase the spread of disease amoung animals.
